

Dear Student,

We look forward to having you with us for the Sankey Rodeo School November 9-10, 2024, to be held at the Mattox Arena, Derby, KS. Check in is at 8:00 am Saturday at the arena. The address is 4418 East 83rd St South, Derby, Kansas 67037.

The closest motel is Sleep Inn and Suites. They're giving our students a great rate of \$75 plus tax a night. Mention Sankey Rodeo Schools when you call to book, 316-425-6077. You can book this rate thru Nov 1.

We'll cover a great deal of information with lecture, drills, demonstration, video, etc. I encourage you to do two things: (1) Be on time. Check-In is at 8:00 am. (2) Bring something to make notes on... and use it. We welcome wives and family members to the school at no cost. Anyone on the grounds who is not family or an enrolled student must be enrolled at least as a Ground School Student; Tuition is \$65.00 if entered by the enrollment deadline and includes everything, drills, lectures, lifetime equipment discounts, classroom sessions, etc. except getting on bucking stock. This policy helps us control distractions and was put in place to protect your investment.

Bring any rodeo gear you have. We'll make sure you have pro quality equipment to use FREE during the school. We will provide everything you need except boots.

You must bring your own boots. As a student you will receive lifetime discounts on equipment purchases, starting at the school. CREDIT CARDS may be used for equipment purchases. Concession stand is CASH only.

The **balance of tuition must be paid two weeks prior to the start of the school**. You may pay online at the website www.sankeyrodeo.com, by phone with a credit or debit card, or mail in the balance due with cashier's check or money order.

Acknowledgment of Risk: The undersigned acknowledges that participation in domestic animal activities on the Premises involves inherent dangers and that participation in such activities exposes the participant to substantial and serious risks, whether foreseen or unforeseen, including, but not limited to, property damage, personal injury, and death. The undersigned expressly acknowledges that participation in domestic animal activities on the Premises will involve such hazards.

Inherent risks of domestic animal activities include, but shall not be limited to: (1) The propensity of a domestic animal to behave in ways ie., running, bucking, biting, kicking, shying, stumbling, rearing, falling or stepping on, that may result in an injury, harm or death to persons on or around them; (2) the unpredictability of a domestic animal's reaction to such things as sounds, sudden movement and unfamiliar objects, persons or other animals; (3) certain hazards such as surface and subsurface conditions; (4) collisions with other domestic animals or objects; and (5) the potential of a participant to act in a negligent manner that may contribute to injury to the participant or others, such as failing to maintain control over the domestic animal or not acting within such participant's ability.

Release of Liability: The undersigned, being fully aware that participation in domestic animal activities on the Premises will expose the participant to substantial and serious risks of property damage, personal injury or death, hereby releases Mattox Arena and Brad J.
